ISBPA Youth / Adult BAKER DOUBLES PINS OVER AVERAGE TOURNAMENT FORMAT & SCHEDULE



1. The Illinois State Bowling Proprietors Association will conduct a Youth / Adult Baker Doubles **Pins Over Average Tournament** with Four Divisions in compliance with the Rules & Regulations specified below. ALL LEVELS OF THIS TOURNAMENT WILL BE CONDUCTED ONLY IN ISBPA MEMBER ESTABLISHMENTS.
2. The Illinois State Qualifying tournament will be conducted in 2 levels:
Center Qualifying Round – October 6, 2018 thru April 7, 2019
STATE FINALS – JUNE 8 & 9, 2019 – CASTAWAYS BOWL, Calumet City, IL
FOUR AGE DIVISIONS: Youth: 11 & Under Boy, 11 & Under Girl, Teen: 12 to 18 years Boy, 12 to 18 years Girl. Adult must be 19 years old or older. All bowlers ages will be as of August 1, 2018. Youths age will determine Division.
3. **FORMAT:** All teams will bowl four (4) Baker-style games during the Center Qualifying Round. The Baker Bowling Format consists of youth & adult alternating frames within a game, to obtain a score together, as a team. The youth bowler will begin games one (1) & three (3), & the adult bowler will begin games two (2) & four (4). Teams bowl all four games on their assigned pair of lanes. At the State Finals teams will bowl **six (6)** Baker-style games. This is a **Pins Over Average Tournament**.
4. **PINS OVER AVERAGE:** During center qualifying, use the highest current Youth & Adult verifiable average of 15 or more games as of date of Center qualifying round. Add the combined teams averages, then multiply that sum by 2. This provides the team's target series.
5. **ADVANCEMENT PROCEDURE:** One team in each Division for each four teams (1:4) entered at the Center Qualifying Round will advance to the State Finals. **If a Division does not have four entries, teams may be grouped into one Division, with the highest overall Pins Over Average score advancing to the State Finals** Notification of advancement to State Finals will come from ISBPA.
No Individual Substitutions are permitted at the State Finals.
6. **MULTIPLE PARTICIPATION:** Is permitted for individuals and teams at the Center Qualifying Round in divisions for which they are eligible. However, a youth may advance to the State Finals once in their respective Division. A **Youth** qualifying in more than one center must advance from where the highest team **Pins Over Average** score was bowled.
An **Adult** may advance no more than three times with a different youth partner. If an adult is listed as qualifying more than 3 times, advancement will be made using the three highest **Pins Over Average** Scores.
7. **AVERAGES – Youth or Adult bowlers without a Current Season's average are ineligible to participate.**
YOUTH: Bowler must use their highest **VERIFIABLE** average for 15 or more games from ANY LEAGUE at the time of entry FOR THE CENTER QUALIFYING ROUND.
ADULT: Bowler must use their highest **VERIFIABLE** average for 15 or more games from ANY LEAGUE at the time of entry FOR THE CENTER QUALIFYING ROUND.
For the State Finals the youth & adult bowlers will use the highest of their Center Qualifying Round entering average (15 or more games) or highest current VERIFIABLE average of 15 or more games as of April 7, 2019.
8. **ENTRY FEES:** The entry fee at the Center Qualifying Round will be **\$25 per team**, (\$10 lineage, \$8 scholarship prize & \$7 expense). There are no additional fees at the State Finals.
9. **DRESS CODE FOR STATE FINALS:**
ACCEPTABLE APPAREL: Slacks, shorts, turtlenecks, sports shirts with collars, T-shirts with a commercially lettered center name/logo, nice jeans and or skirts are acceptable.
UNACCEPTABLE APPAREL: (includes but is not limited to) tank tops, cutoffs, T-shirts that advertise alcohol, drugs or explicit material, jeans with holes or patches, hats or headgear and or boxer type shorts.
The tournament director on-site has final decision.
10. **All matters not covered by these rules will be decided by the ISBPA Youth Committee or ISBPA Tournament Director and all decisions of same shall be final.**
